

OUR POLICY CONCERNING THE CORPORATE PRIVACY

This privacy policy explains how our company uses personal data which are provided to us directly. The following information are only available for the <https://deriplastgroup.it> site and not for third-party websites accessible through hyperlinks included inside the Website.

WHO IS THE OWNER OF PERSONAL DATA PROCESSING?

The owner of processing is **Deriplast Group s.r.l.**, placed in Villadose (RO), via San Leonardo, n. 2, f.c. and p.iva 01542780299, p.e.c. deriplastgroup@legalmail.it in person of legal representative *pro tempore*, which is a society belonging to System Group, led by the HB Boscarini s.p.a. society that is the *holding* of the group (group e-mail address privacy.systemgroup@tubi.net)

WHICH ARE THE PERSONAL DATA WE COLLECT?

When we talk about “personal data”, we refer to data of the subject which can be a website viewer, a client or a potential client.

Personal data includes name, e-mail address, telephone number, company, district and other information that are inside the message.

We process data that are provided intentionally by the user, through the filling of form placed in some sections of the Website or through the sending of messages to e-mail addresses you can find in the Website, in order to provide services offered through it.

HOW AND WHY WE USE YOUR PERSONAL DATA?

The personal data provided by user will be processed for the following purposes:

- A. **Answer to the user requests** with regard to data provided through filling of the “contacts form”, in order to answer to your requests concerning information, quotation or any type of request inside the message. One of our coordinator will get in touch with you in order to detect requests or plan a meeting. If we can't process data we won't be able to satisfy your requests.
In these situations, processing of your personal data is essential in order to carry out pre-contractual measures.
- B. **Marketing**
 - b.1 In order to update you on news and commercial offers concerning our products, services and third-parties; to invite you to events, to conduct market researches or other type of commercial activities and customer satisfaction both through communication channels (like phone call from an operator) and through automatic communication tools like e-mails, chats, messages (like SMS and other type of instant messaging) and other tools of remote communication - newsletters.
 - b.2 In order to share your personal data with other companies of the group and/or trading partners belonging to our sales network, for the sending of marketing communications and other type of commercial activities like those specified in b.1.

Processing of your data for newsletter subscription and marketing purposes is not imperative. In these cases your data could be processed only after your explicit permission (entirely optional), revocable at any time without consequences.

HOW LONG DO WE KEEP YOUR DATA?

These processed data will be kept for a limited period of time. At the end of this period, the data will be deleted or made anonymous. The storage period is different depending on the processing purposes, in particular:

- Those data provided through the messages sent by e-mail or obtained through the filling of the contact forms that are on the website will be kept for the time required to provide an answer;
- Concerning marketing and newsletters sending, data will be processed until the unsubscription to the service or for no more than 24 months starting from the date the permission is provided, renewed.

PROCESSING METHOD

Personal data are processed with automatic tools for a period of time that is required for achieving the purposes the data have been collected for. Specific safety measures have been put in place in order to prevent the data loss, illegal or incorrect use and non-authorized access.

TO WHOM YOUR DATA ARE DISCLOSED?

Your personal data are disclosed to:

- Collaborators and employees specifically authorised and trained by the Owner as part of his/her specific skills and tasks;
- Providers of services offered through the Website or connected to its functioning that act in the role of processing managers (ex. hosting and newsletter web service);
- Eventual services societies, in order to accomplish services of secretary, marketing and communication with particular attention to answer requests coming from users, the organization and development of marketing activities and campaigns;
- Other companies of the group and/or trading partners belonging to our sales network (only if you give us your permission) in order to send newsletters, marketing communications and other commercial activities (like those mentioned in the B letter).

Other than the above cases, the personal data will not be communicated, spread, gave or transferred to third-parties for illicit purposes or not connected to the above aims. In any case, the personal data will not be released without giving the appropriate policy to the subjects and without having their permission, if requested by the Law.

It is without prejudice the possible data communication upon request of the Judicial Authority or Public Safety, following the methods and cases required by the law.

TRANSFER OF YOUR DATA IN THIRD-PARTIES COUNTRIES

Your personal data could be transfer abroad, even in extra EU countries, only after the verification of standard contractual terms approved by European Commission (GDPR art. 46), or binding rules for the company (GDPR art. 47), or, without the previous terms and rules, on the basis of one of the exemption measures according to GDPR art. 49.

YOUR RIGHTS REGARDING DATA PROTECTION

Our company wants to be sure you are entirely aware of all your rights regarding data protection. Every single user has the following rights:

Access right - You have the right to ask our company for copies of your personal data. We could charge you a small fee for this service.

Rectification right - You have the right to ask our company to correct every information you consider inaccurate. You also have the right to ask our company to complete the information you consider incomplete.

Cancellation right – you have the right to ask our company to delete your personal data.

Processing restriction right - you have the right to ask our company to restrict the processing of your personal data in accordance with the hypothesis specified in GDPR art. 18.

Right to oppose to the processing – you have the right to oppose to the processing of your personal data from our company for marketing and profiling purposes.

Data portability right - you have the right to ask our company to transfer the data we collected to another company or directly to you, in accordance with the hypothesis referenced by GDPR art. 20.
