WHO IS THE OWNER OF PERSONAL DATA PROCESSING?

WHICH ARE THE PERSONAL DATA WE COLLECT?

Every time a user uses or visit our website, we collect the following data:

Browsing data. IT systems and software processes in charge of website operation gain (during a normal service) some personal data that are transmitted automatically by using the Internet communication protocols. This data category includes: IP addresses or domain names of computers and devices used by users, URI/URL addresses (Uniform Resource identifier/Locator) of requested resources, request hour, method used for making the request to the server, file dimension obtained as response, numeric code that shows the status of the response gave by the server (successful, error, etc.), and other parameters related to the operating system and the user computing environment, For further information please refer to cookies policy of this website.

Cookies. Cookies are small text files that websites visited by users send to their terminals to be stored in order to be retransmitted to the same websites for future visits. Cookies have various purposes, different characteristics, and they can be used by both visited website owner and third-parties. PROCESSING PURPOSE, LEGAL BASIS, DATA STORAGE PERIOD AND DATA PROVISION NATURE

Our Company collect your data in order to allow **you to explore the website**.

- **LEGAL BASIS:** legitimate interest (art. 6 part 1 letter f) and considering GDPR 47: processing is necessary for legitimate interest pursuit of the owner of processing or of third-parties, as long as interests or rights and basic freedom (that request personal data protection) of the subject don't overcome. Reasonable subject's expectations are took into account based on his/her relationship with processing owner. This is an essential activity for website functioning and the serving delivery of browsing on the platform.

- **DATA PROVISION NATURE:** it is necessary in order to allow website browsing.

TO WHOM YOUR DATA ARE DISCLOSED?

Your personal data are disclosed to:

- Collaborators and employees specifically authorised and trained by the Owner as part of his/her specific skills and tasks;
- Providers of services offered through Website or connected to its functioning that act in role of processing managers (ex. hosting web service);
- Third-party company or consultants in charge of installation, maintenance, updates and, in general, management of website's hardware and software;

Other than the above cases, personal data will not be communicated, spread, gave or transferred to third-parties for illicit purposes or not connected to the above aims. In any case, personal data will not be release without giving appropriate policy to the subjects and without having their permission, if requested by Law.

It is without prejudice the possible data communication upon request of the Judicial Authority or Public Safety, following methods and cases required by law.

TRANSFER OF YOUR DATA IN THIRD-PARTIES COUNTRIES

Your personal data could be transfer abroad, even in extra EU countries, only after the verification of standard contractual terms approved by European Commission (GDPR art. 46), or binding rules for company (GDPR art. 47), or, without previous terms and rules, on basis of one of the exemption measures according to GDPR art. 49.

YOUR RIGHTS REGARDING DATA PROTECTION

Our company wants to be sure you are entirely aware of all your rights regarding data protection. Every single user has the following rights:

Access right - You have the right to ask our company for copies of your personal data. We could charge you a small fee for this service.

Rectification right - You have the right to ask our company to correct every information you consider inaccurate. You also have the right to ask our company to complete information you consider incomplete.

Cancellation right – you have the right to ask our company to delete your personal data.

Processing restriction right - you have the right to ask our company to restrict processing of your personal data in accordance with hypothesis specified in GDPR art. 18.

Right to oppose to processing – you have the right to oppose to processing of your personal data from our company for marketing and profiling purposes.

Data portability right - you have the right to ask our company to transfer data we collected to another company or directly to you, in accordance with hypothesis referenced by GDPR art. 20.
